Information and Referral

- Opened an office in Pelham in Feb. 2009
- Served 5094 families
- Published and distributed 5000 copies of our Spanish language resource guide,
- *Bienvenidos a Birmingham*
- Provided food and clothes to 40 families (107 children) at Christmas



Domestic Violence

- Reinstated bilingual court advocate in Birmingham Municipal Court and Jefferson Co. District Court
- Assisted 135 immigrant victims of domestic violence through the 24/7 Spanish hotline.
- Referred 35 women to shelter
- Placed a bilingual case manager in Safe House of Shelby County to serve immigrant victims better
- Provided mental health counseling to 17 women (68 1 to 1 sessions between January and April)



Family Legal & Immigration Services Program

- Hired a bilingual immigration attorney
- Established partnership with Cumberland School of Law to provide externship opportunities for law students

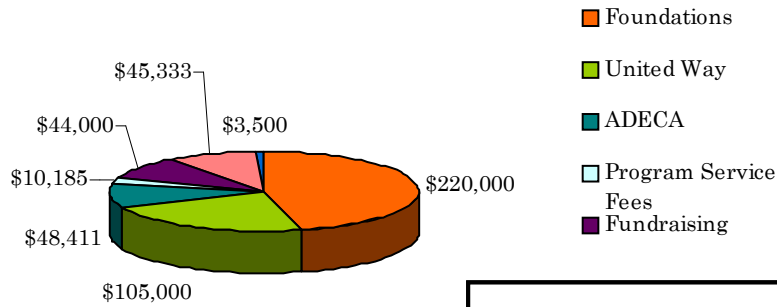


Community Outreach and Education

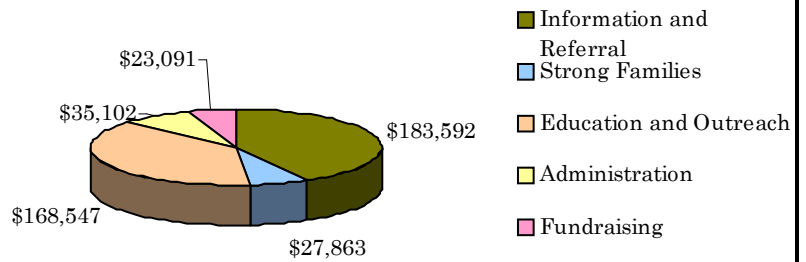
- Taught 143 immigrants English through ESL classes
